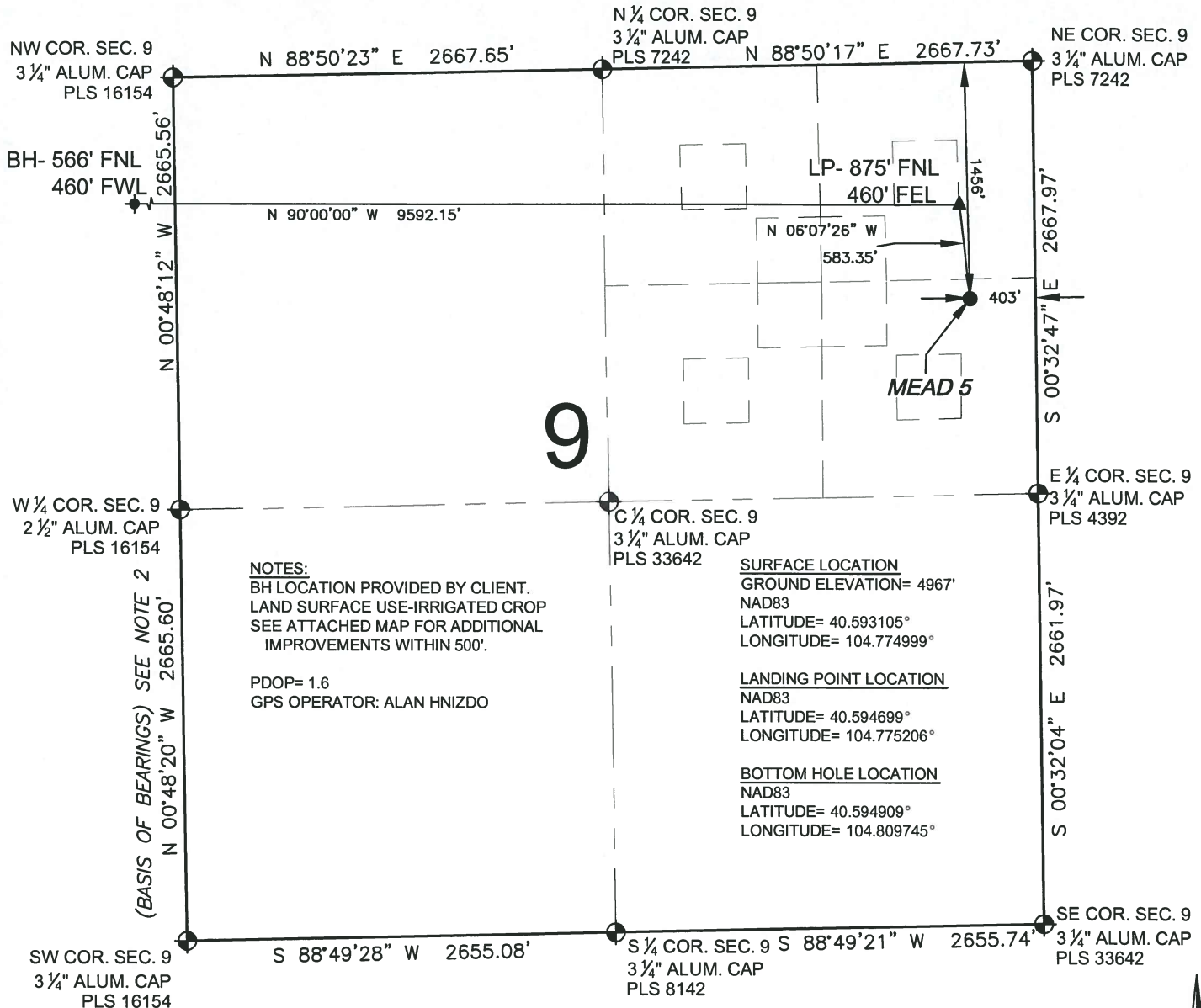


WELL LOCATION CERTIFICATE: MEAD 5

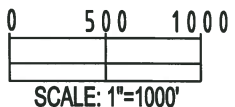

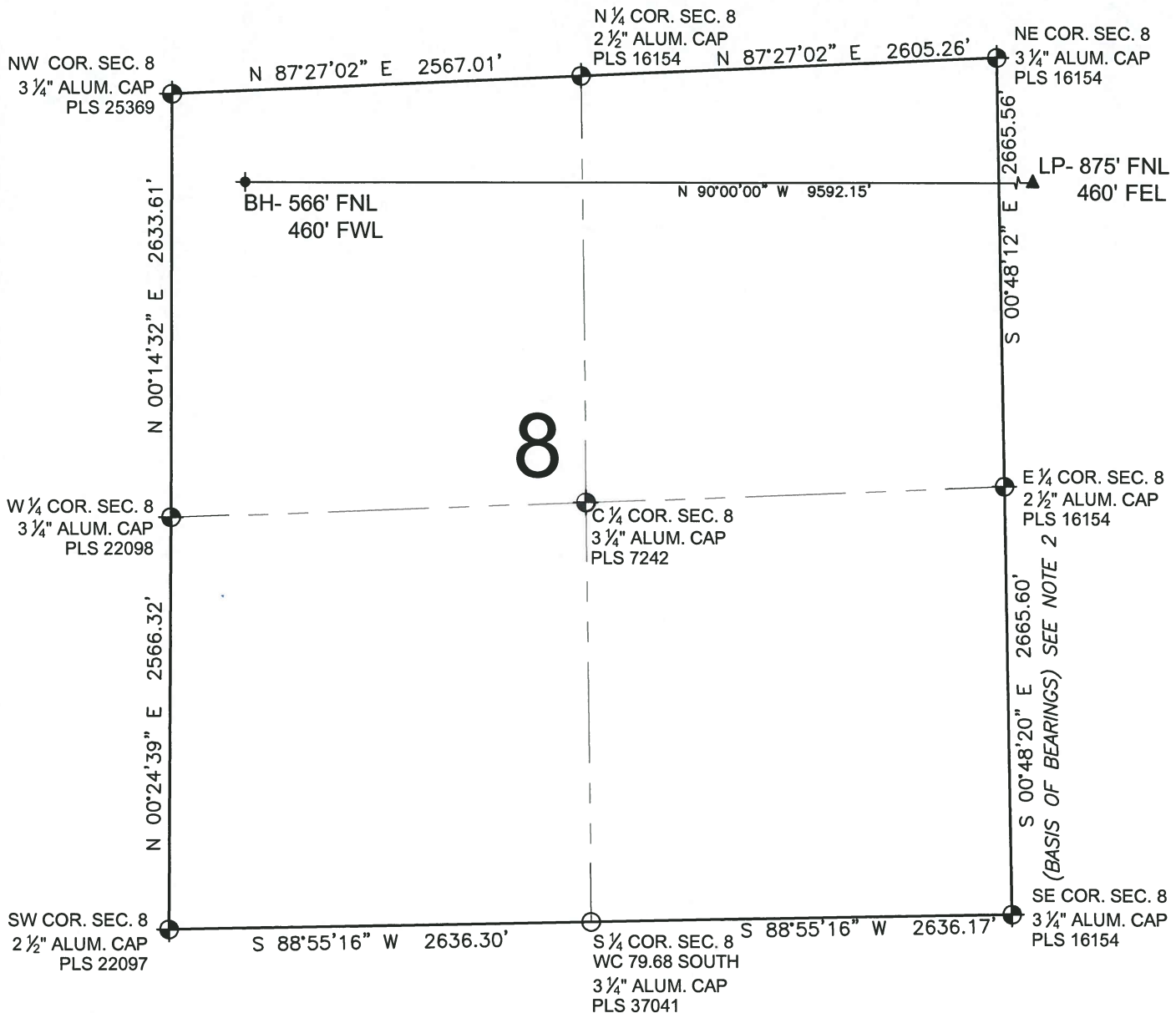

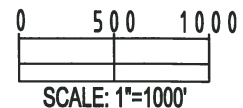
