Extraction Oil & Gas LLC (Extraction) plans to drill the above referenced wells, specifically described as:

<b>Mead 1</b>	<b>1352' FNL, 402' FEL, Section 9-T7N-R66W</b>
<b>Mead 2</b>	<b>1378' FNL, 403' FEL, Section 9-T7N-R66W</b>
<b>Mead 3</b>	<b>1404' FNL, 403' FEL, Section 9-T7N-R66W</b>
<b>Mead 4</b>	<b>1430' FNL, 403' FEL, Section 9-T7N-R66W</b>
<b>Mead 5</b>	<b>1456' FNL, 403' FEL, Section 9-T7N-R66W</b>

The wells are being proposed at a distance less than the required 150 feet from a surface property line, as described in COGCC Rule 603.a.(2), which states that a well "...shall be located not less than 150 feet from a surface property line.".
