Extraction Oil and Gas, LLC (Extraction) is planning to drill the above referenced well in accordance with the provisions set out in COGCC Rule 318A.e. Extraction's proposed wellbore spacing unit consists of:

Containing 360 acres more or less

Extraction is not the only owner within the proposed wellbore spacing unit and has provided notice to the remaining owners within this spacing unit, as required by COGCC Rule 318A.e.(6). 

WELL MEAD 5 TO BE LOCATED 1456' FNL AND 403' FEL, SEC. 9, T7N, R66W


SURFACE LOCATION
