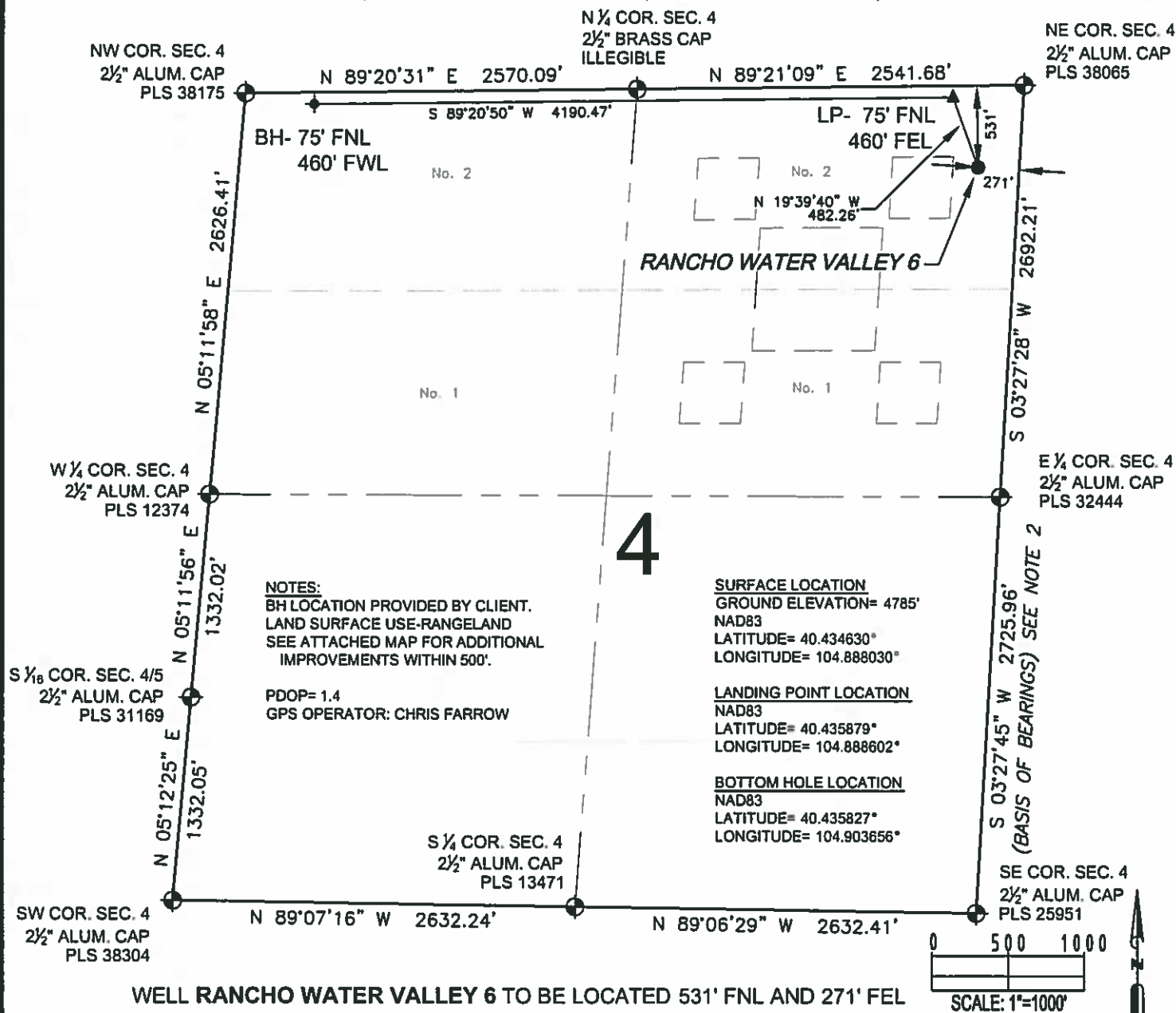


WELL LOCATION CERTIFICATE: RANCHO WATER VALLEY 6

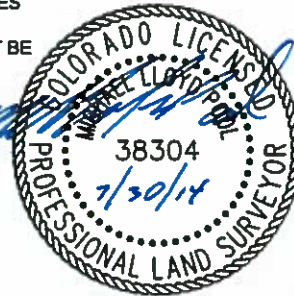
- = EXISTING MONUMENT
