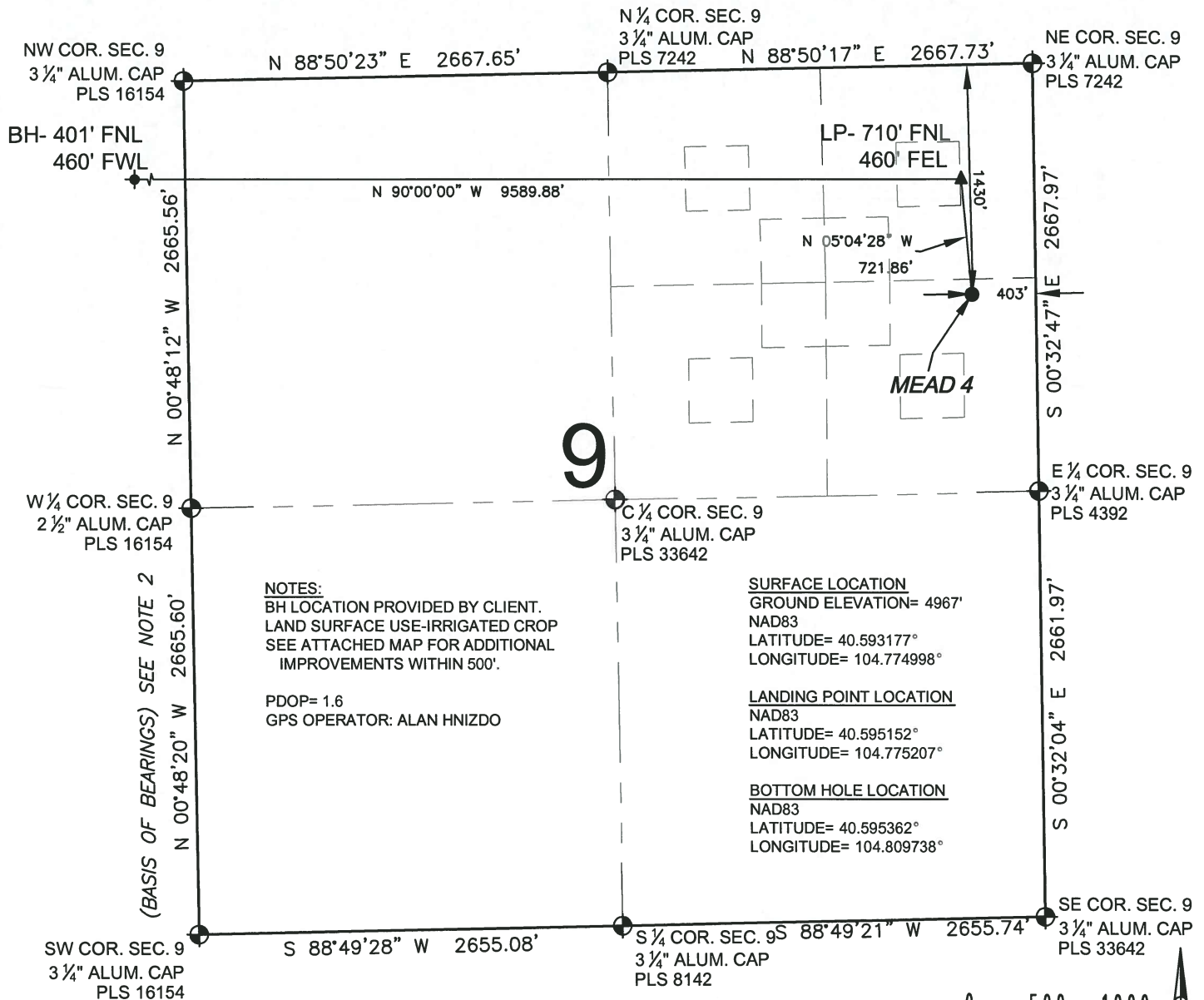


# WELL LOCATION CERTIFICATE: MEAD 4

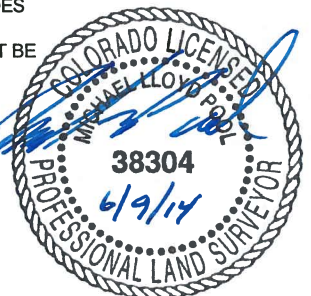

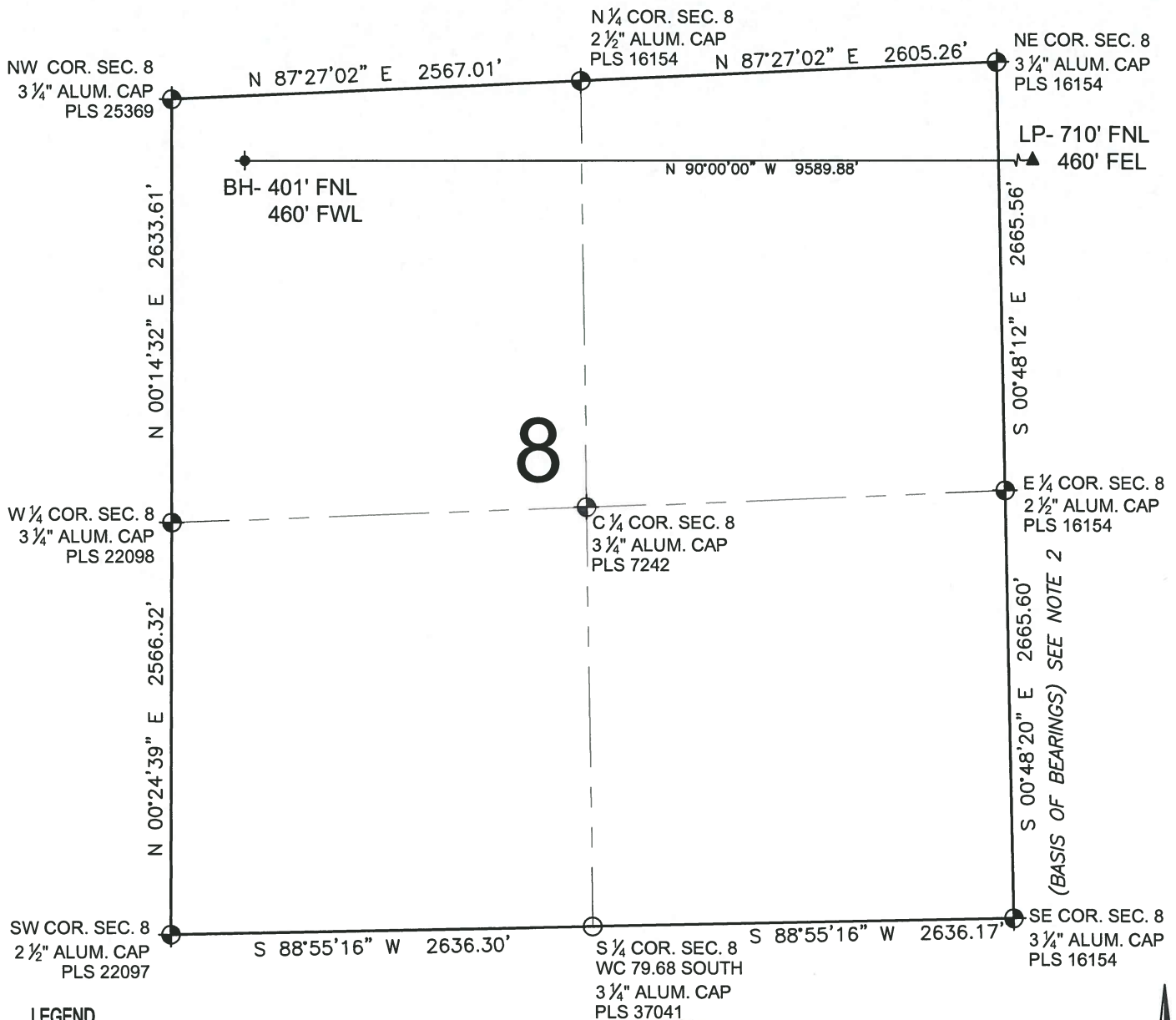

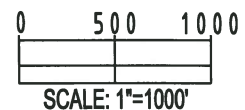
