Dear Mr. Buchanan,

This letter is to advise you it is our intent to commence drilling operations for a natural gas well in the above referenced location. This proposed gas well location is approximately 700' Southeast of your residence. Per COGCC rule 305.a.2 it is our obligation to notify you of this proposed gas well. If you have someone renting the residence please provide them with this information.

Please see attached map for an aerial reference of the gas well in proximity to your home. Since the surface use of the gas well location is in CRP we hope to commence drilling operations during the 3rd quarter of 2014. We will contact you prior to moving onto location as we learn the approval date of the APD, rig availability and title approval.

If you have any questions or concerns you may request a meeting with us at the number below or you may request a meeting with the Local Government Designee (LGD), Linda Briggs. Linda can be reached at the County Commissioners Office at 970-332-5796.

We are required to provide you with 30 days notice prior to our submitting the Oil and Gas Location Assessment (Form 2A). COGCC Rule 305.c. gives you the right to submit written comments about the proposed location to the Director, the LGD and to Augustus Energy Resources LLC, as well as receiving the Form 2A, the major equipment list, a plat showing visible improvements within 500' of the location and a topo map showing the proposed access route and the COGCC hydraulic fracturing informational sheet. We will provide you with the information referenced above unless you waive your right to receive these documents.
