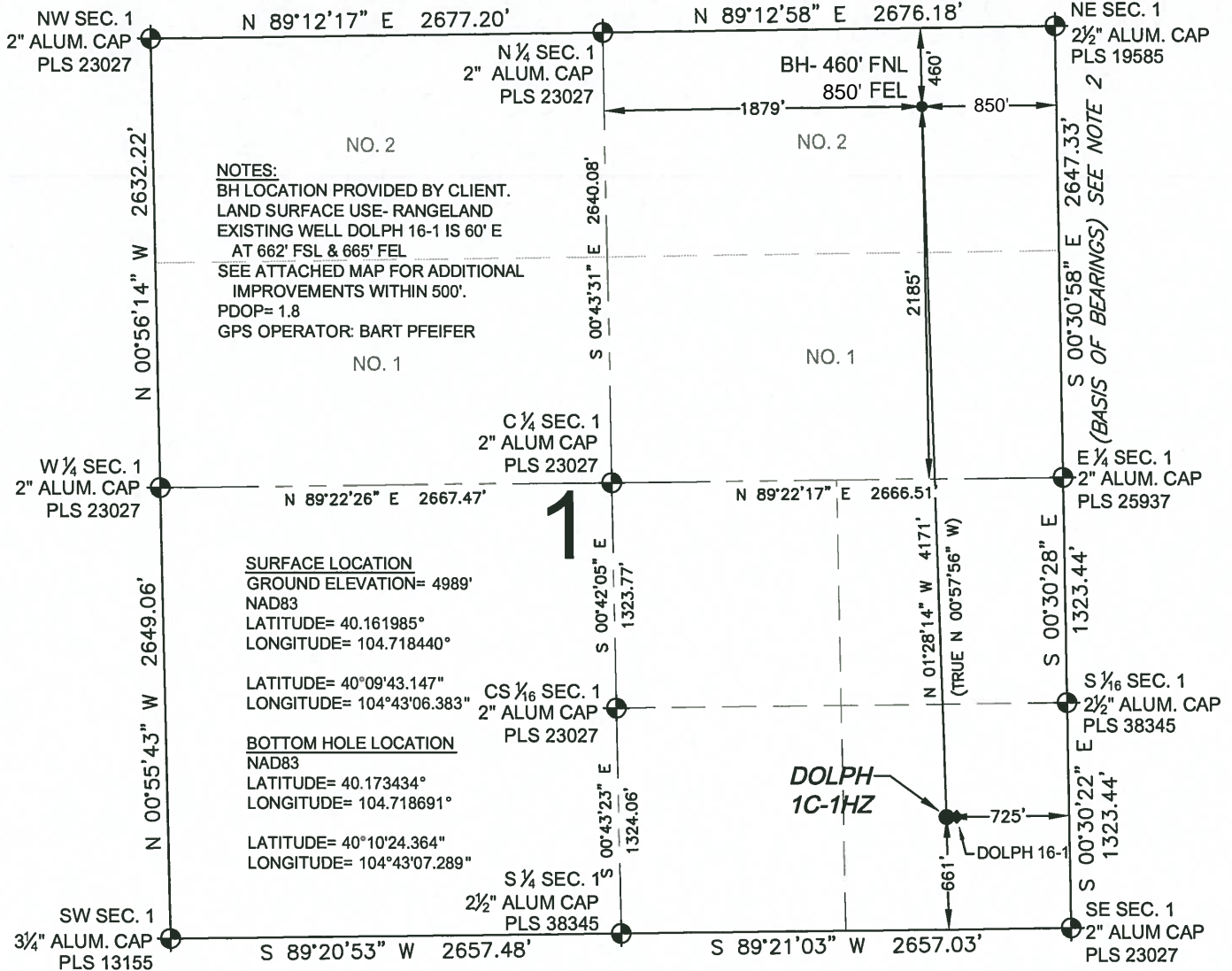


# WELL LOCATION CERTIFICATE: DOLPH 1C-1HZ

## LEGEND

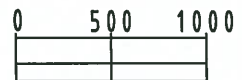
- ⊕ = EXISTING MONUMENT
