1. Pull tubing string, trip casing scraper through existing production perforations. Set RBP @ 7070 ft.
2. PU 4-1/2" casing & decentralize. Run 1-1/4" tubing down 4-1/2" x 8-5/8" annulus to 1500'.
3. Pump cement from 1500 ft to surface.
4. POH 1-1/4 tubing. Re-land 4-1/2" casing in WH.
5. SI for 48 hrs.
6. Run new CBL f/ 2500' to Surface.
7. Retrieve RBP and return to production.
