K.P. Kauffman Company, Inc. (KPK) has increased the size of the disturbed area of the above referenced production location. This facility serves as a production location for the wells in the attached spreadsheet. The surface location of KPK's facility has been mutually negotiated with the surface owner in order to install five (5) additional Emission Control Devices (ECD) and a compressor. This construction took place or around July 7, 2014 to address imminent safety concerns following a COGCC inspection of the Facility.

In consideration of the foregoing, KPK kindly requests that current setback rules contained in Rule 604.b.(1).A. be waived for this permit application given that is being filed as a result of additional disturbed area on an existing location.
