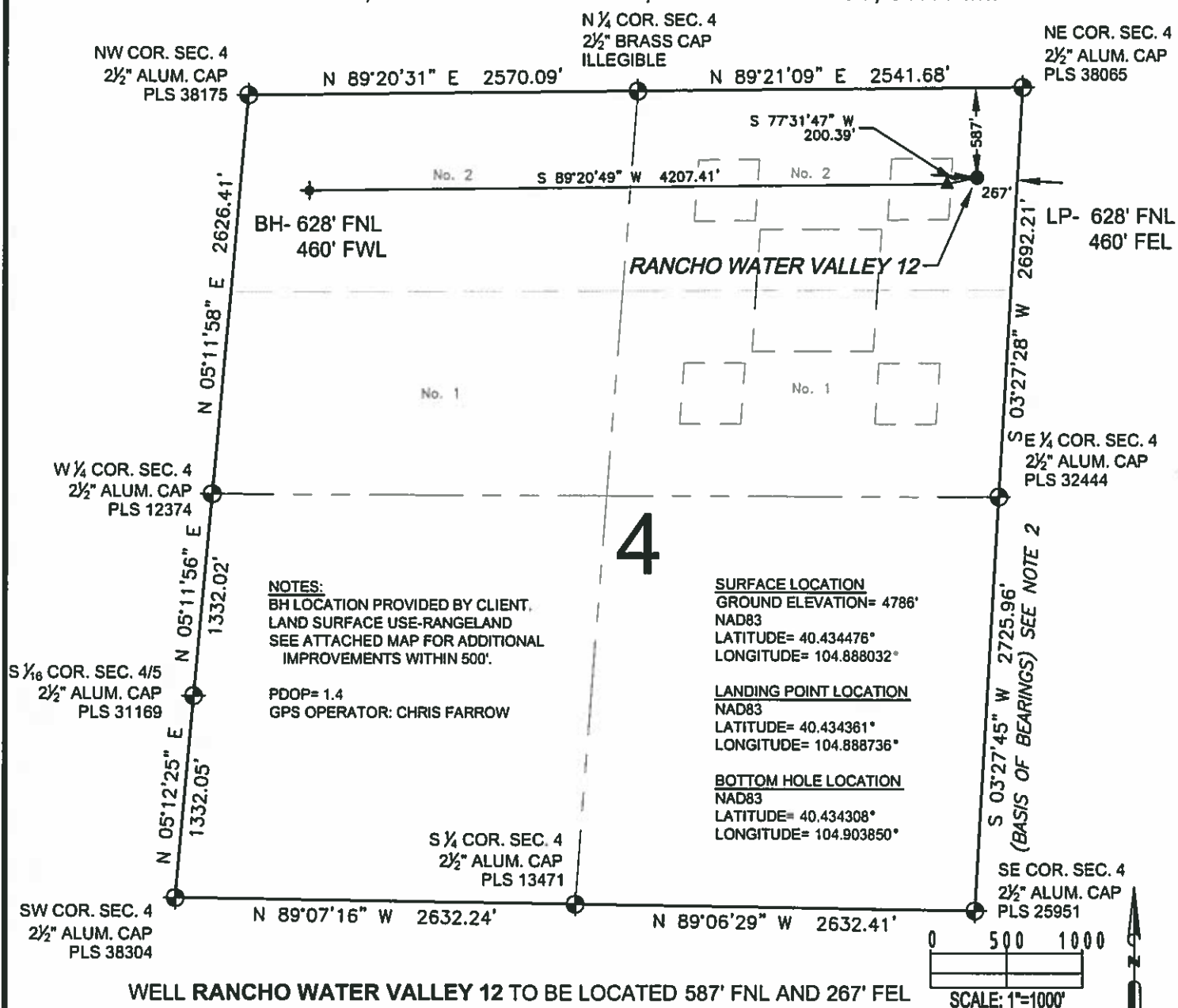


# WELL LOCATION CERTIFICATE: RANCHO WATER VALLEY 12
