Comment: Signs of a recent workover on the well suggests that the tubing has probably been replaced, a packer possibly run in on the end of the tubing and a 2000 pound wellhead replaced with a 5000 pound wellhead. However, the wellhead is not plumbed up to the flowline and has no way of producing in the current configuration; therefore, the well, by definition, is temporarily abandoned. No signage at wellhead, as Kerr McGee is wont to do, to communicate why the well has been temporarily abandoned.
