Extraction Oil and Gas, LLC (Extraction) is planning to drill the above referenced well in accordance with the provisions set out in COGCC Rule 318A.e. Extraction's proposed wellbore spacing unit consists of:

Rancho Water Valley #12
W/4 NW, E/4 NW, W/4 NE, E/4 NE
NENE: Section 4, Township 5 North, Range 67 West.
Consisting of 160 acres more or less.

Extraction is not the only owner within the proposed wellbore spacing unit and has provided notice to the remaining owner(s) within this spacing unit, as required by COGCC Rule 318A.e.(6). Copies of the required notification letters are on file at Extraction's office. The required thirty (30) day notice period has elapsed absent the receipt by Extraction of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well.

Enclosed is the Proposed Spacing Unit Plat to assist in your review and approval of Extraction's proposed Application for Permit to Drill (APD) for the Rancho Water Valley # 12 well. Extraction respectfully requests the COGCC review the enclosed information and approve the requested exception location waiver and APD for the Rancho Water Valley #12 well.



LANDING POINT LOCATION


