Dejour/Coachman as Operator of the PWD Federal 21-6-91 respectfully requests approval to move the surface hole location (SHL) approximately 101 feet to the North-Northwest of the originally permitted location:

New Location: 1831' FEL x 880' FSL, Section 21, T6S, R91W, 6th PM, Garfield County, Colorado

Old Location: 1782' FEL x 791' FSL, Section 21, T6S, R91W, 6th PM, Garfield County, Colorado

The move is necessary for operation reasons as it will be a better location for PWD Federal 21-6-91 to service the well from a drilling position and to avoid locating the well immediately adjacent to the four (4) producing natural gas wells on this well pad (21A). Also, since this well is to be a produced water disposal well this new location will be better suited for the wellhead, disposal lines, and future workovers, as well as for situating the new surface facility equipment to have it located approximately 100 feet away from the producing gas wells. Attached is the revised directional plan with the same permitted Bottom Hole Location (BHL).
