Noble respectfully requests approval to change the surface hole location of the subject well for the purpose of reducing well density in this area. The Lease, Spacing, Pooling information, Casing Point and bottomhole location will not change. A revised Well Location Plat, Directional Drilling Plan and Directional Data Template spreadsheet are attached. The Total Measured Depth (TMD) will change from 14,524' to 14,618'. Noble also requests Confidential Status due to a first full section development which will include 60-acre spaced wellbores including a combination of extended reach laterals (~9,000 ft.) and normal reach laterals (~4,000 ft.).
