Noble respectfully requests approval to change the surface hole location of the subject well for purpose of reducing well density in this area. The Lease, Spacing, and Pooling information, casing point and BHL locations will not change. A revised well location plat, directional drilling plan, directional data template spreadsheet are attached. Total Measured Depth (TMD) will change from 14,649' to 14,670'. Noble also requests Confidential Status due to a first full section development which will include 60-acre spaced wellbores including a combination of extended reach laterals (~9,000 ft.) and normal reach laterals (~4,000 ft.).
