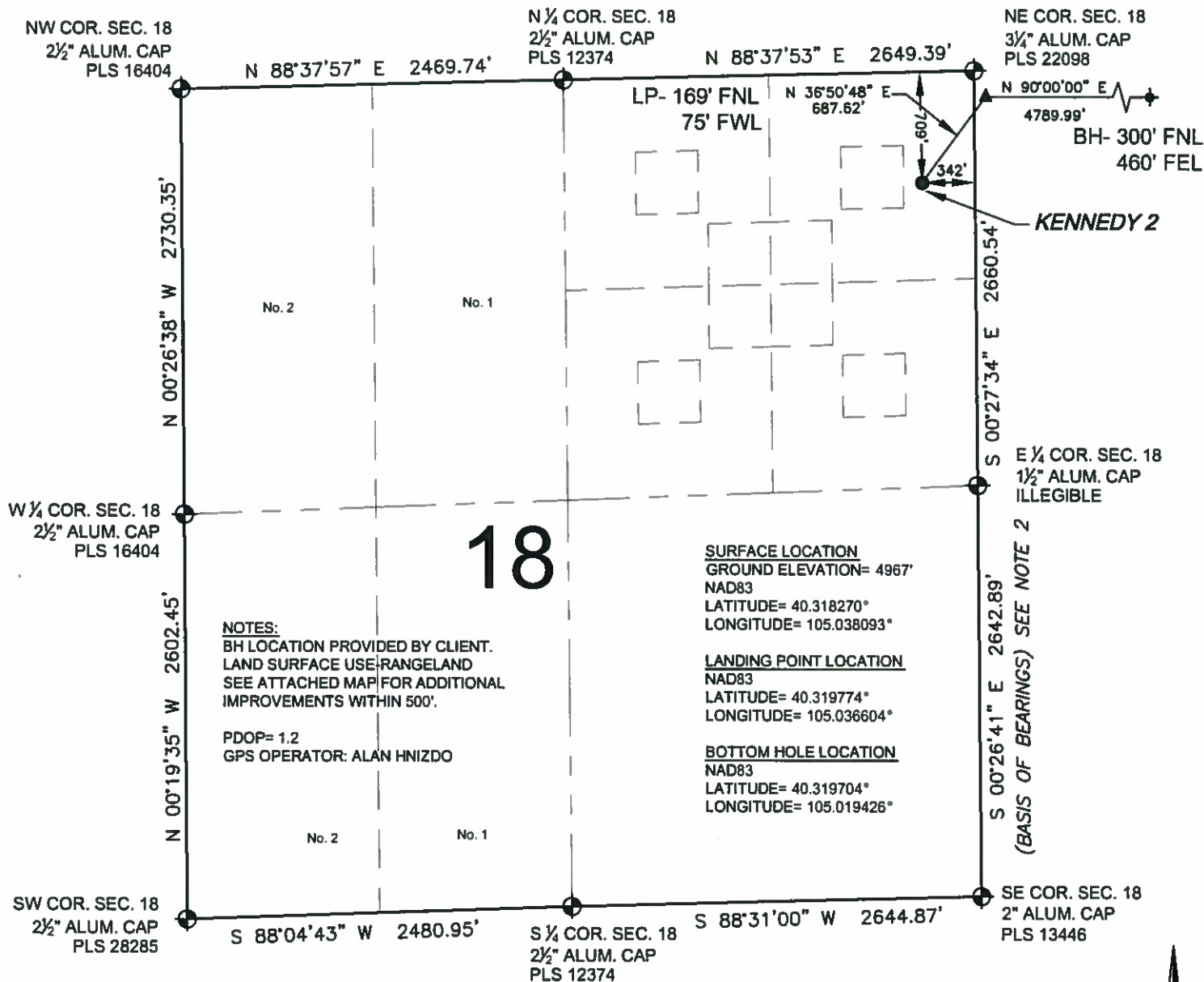


# WELL LOCATION CERTIFICATE: KENNEDY 2

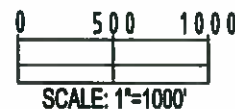

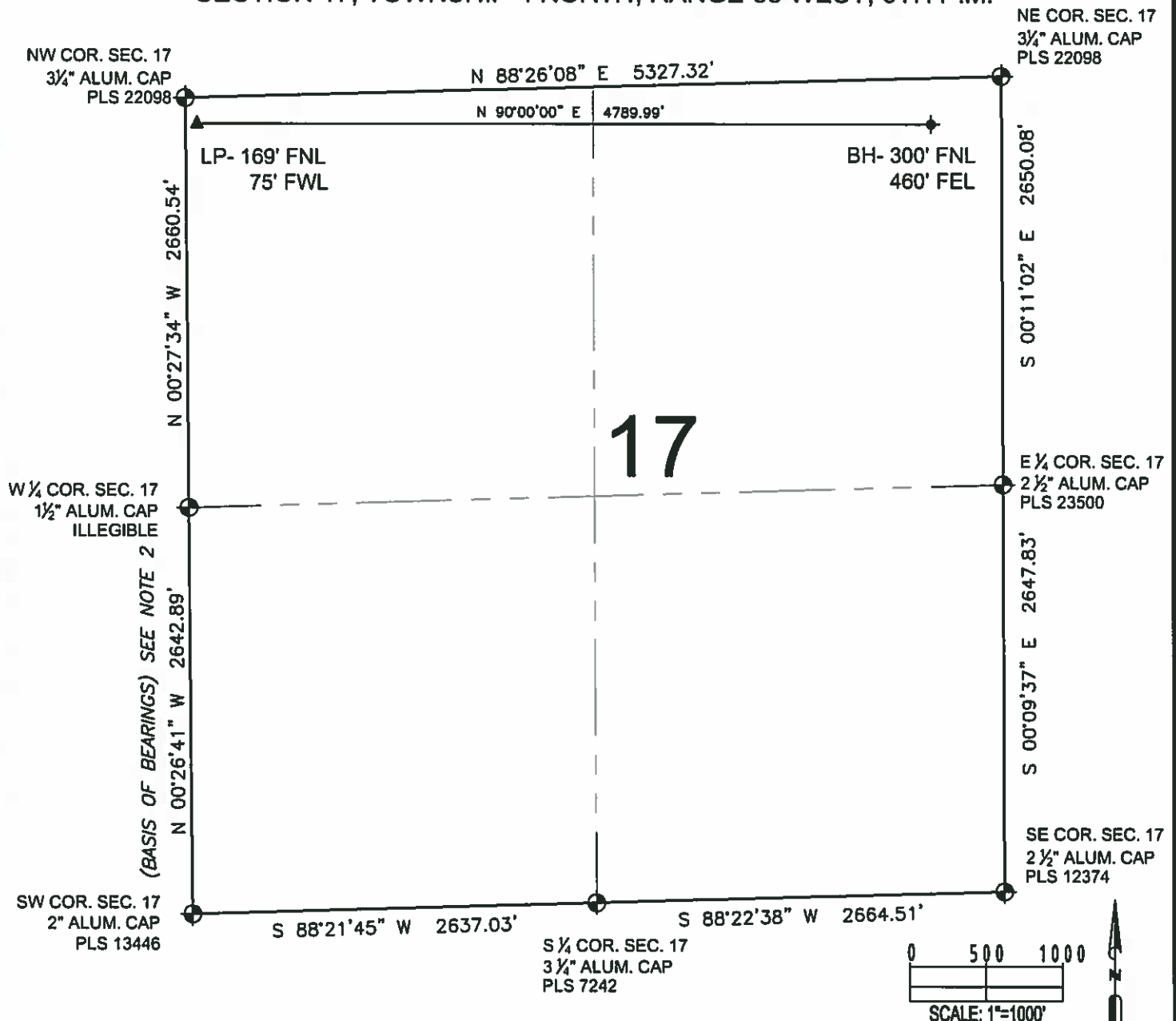
