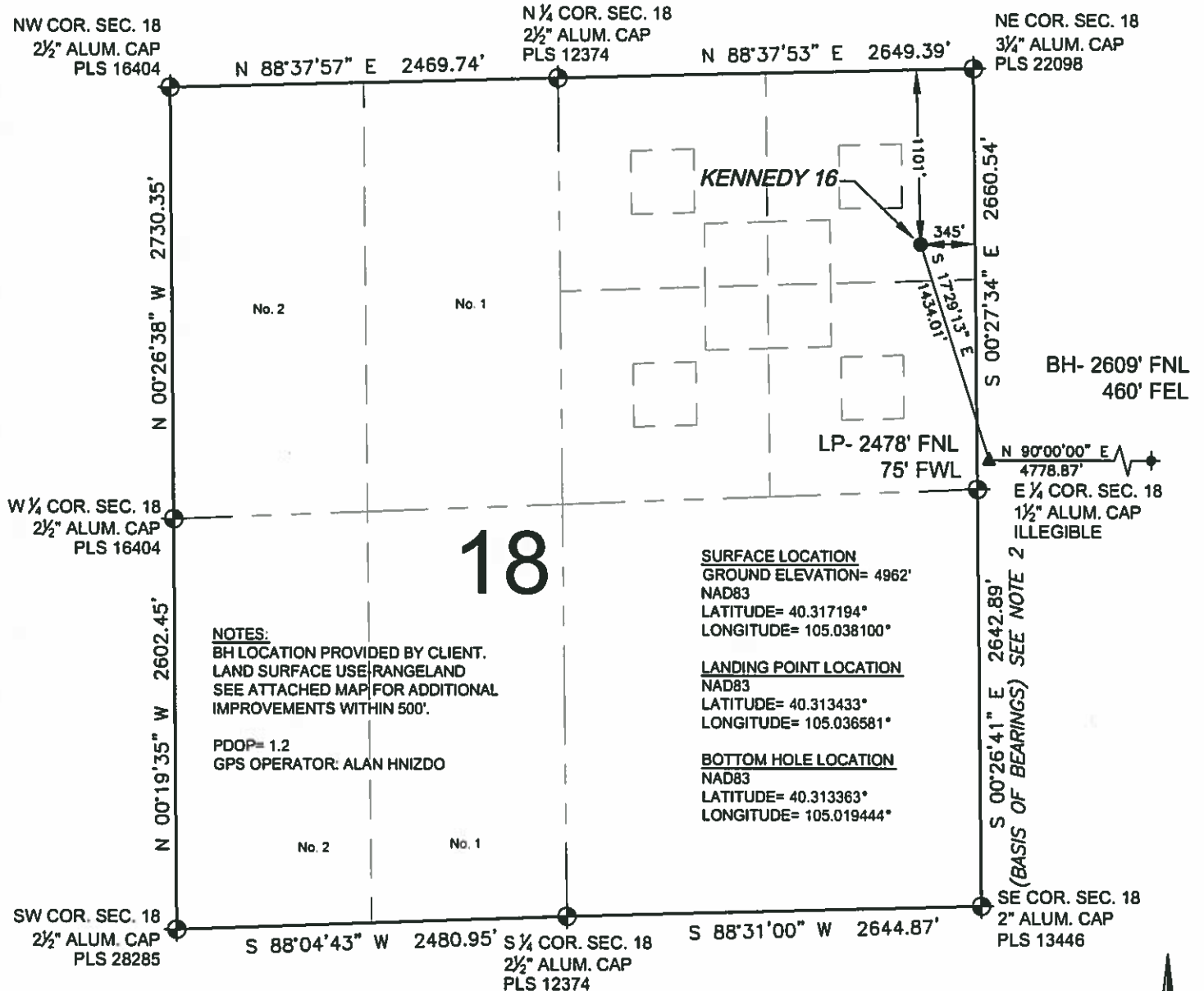


WELL LOCATION CERTIFICATE: KENNEDY 16

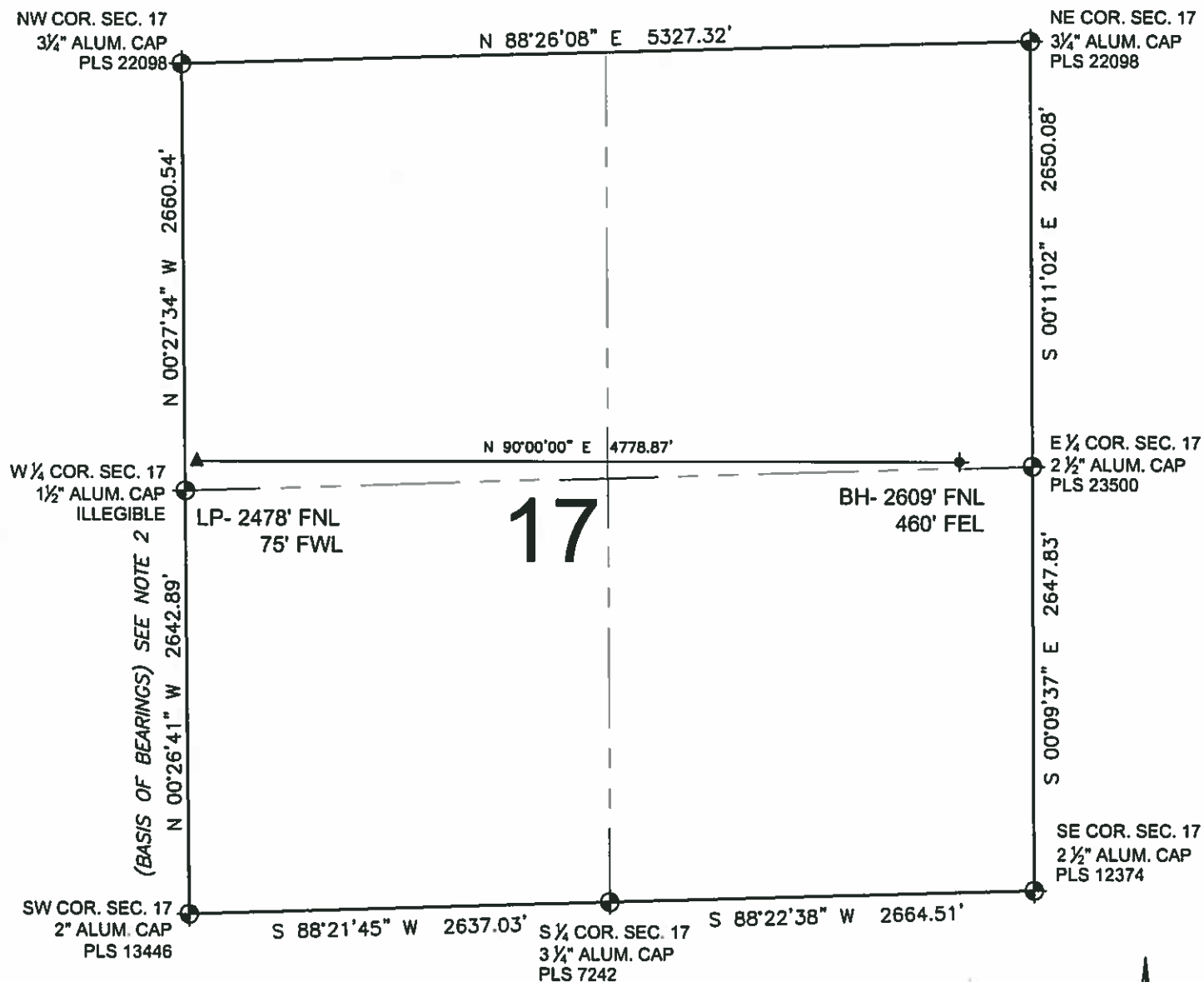
