Future plans for the well -- The Dunbar 2 well was originally completed in the Lyons Sandstone. The Lyons and the J Sandstone perforations are both isolated from the surface with cast iron bridge plugs. The reason we would like to carry the Dunbar 2 as a T&A well is in event we should need to use the Lyons Sandstone for water disposal. The well is closed to the atmosphere with a 5 1/2" X 2" swedge (on top of the production casing) and a 2" ball valve.
