OPERATOR HAS FAILED TO COMPLY WITH LAWS THAT PROTECT HUMAN HEALTH AND THE ENVIORNMENT. EXPOSURE TO GASEOUS SUBSURFACE LEAKING OF HYDROCARBONS CAN CAUSE LUNG CANCER. VIOLATIONS OF THE GENERAL DUTY CLAUSES OF THE CLEAN AIR ACT AND THE CLEAN WATER ACT WERE REPORTED IN 2013 TO COGCC. COGCC ACTION TO CAP IS STRONGLY RECOMENDED TO PROTECT HUMAN HEALTH AND ENVIORNMENT LAWS.
