Thursday (08-21-2014) at approximately 11:50AM a Water Injection leak from a backflow Tank on location FEE 91X. API 05-103-07573.LAT -LONG (40.11409162,. 108.8388857). Appox 15 BBLs of produced water was released and .5 bbls Oil. The Backflow was shut down immediately upon detection. Vacuum truck removed all of the free fluid; estimated recovery was approximately 15 BBLs and all impacted soil was taken to the landfarm for remediation. All fluids were contained within the Well Berm.
