The Rancho Water Valley #12 was mistakenly spud at the Rancho Water Valley #10 slot.  
The very northern most slot was permitted/sundried as the Rancho Water Valley 10. The sundried Rancho Water Valley 12 slot should have been the 5th slot down from the north.  
To fix this, Extraction wishes to move the slots for the RWV 10, RWV 7, RWV 6, RWV 4 down one slot each.  
The 10, 7, 6, & 4, the wells will be moving 28' south for each. RWV #12 is 112' north of its planned surface slot.  
New drilling plans and A/C reports are attached. A hand drawn location plat which shows the new surface hole locations is attached.
