The rig is currently being moved on site; spud expected around 9/7, drilling, setting surface casing and then the new plans for production casing forward expected to start around 9/16 and why that date is being used as start date.

There reason for this design change is that KM plan testing the borehole and may or may not choose to drill out the permitted horizontal borehole depending on test result.
