Hawkins 11-13 Pad – Equipment Relocation and Storm Water Re-route

On May 25, 2014, a landslide occurred at West Salt Creek approximately 11 miles southeast of the town of Collbran, Colorado. The landslide impacted the Hawkins Ranch 11-13 pad, COGCC location #334404. The area of the slide is estimated at ½ miles wide and 3 miles long.

The equipment on the Hawkins Ranch 11-13 pad consists of 3 producing gas wellheads, a separator with housing, and a tank battery. Debris from the slide flowed from the top of a hill and ended around the eastern edge of the pad. At the pad, debris is piled about 30 feet from grade. Part of the ending-toe of the debris encroached onto the pad's eastern edge causing minor damage to pig launcher's above ground riser.

It is OXY's intention to move the current pad equipment from the east side to the west side of the pad, starting as early as next week. The equipment move plan is as follows:

A) Roustabout crew to route storm water flow, relocate tank battery and production unit, install piping

- a. Stormwater Routing – See Figure 1
  - i. Construct berm to direct flow to the SW area of slide
  - ii. Excavate path for natural water flow through west side of well pad
  - iii. Roll slide area at corner of pad, cover in top soil, and seed
  - iv. Excavate area near access road
    - 1. Remove or push dirt away from road
    - 2. Rebuild bar ditch
- b. Facilities Move – See Figure 2
  - i. Tank Battery
    - 1. Disconnect and remove tank battery piping
    - 2. Ensure no liquids are in tanks prior to moving
    - 3. Clean and dismantle containment, dispose of liner
    - 4. Build new containment at SW corner – Straight Line Installation
    - 5. Install spray liner
    - 6. Install tank pads
    - 7. Re-install tanks and piping
  - ii. Separator
    - 1. Disconnect and remove 3-pack's piping
    - 2. Level and install 3-pack near NW corner
    - 3. Build new 2" Sch 80 header for dumps
  - iii. Re-route Piping
    - 1. Disconnect and abandon existing production lines, dump lines, and gas sales line
    - 2. Install new 2" XS production lines from wells to separator
    - 3. Construct new 4" launcher, install near separator
    - 4. Hydro-test the 4" line from Hawkins Ranch 11-13 – 10-9 pad
    - 5. Route new 2" Sch 80 dump lines to tanks
    - 6. Install new 4" gas sales line from separator and tie-in to existing 4" sales line

B) Automation

- a. Shut down power, move PLC, Solar and communication tower to NW corner, near separator
- b. Utilize new trenching for 2" conduit
  - i. 18g Belden wire to wellhead J-box for plunger arrival and pressure transducers
  - ii. 18g Belden wire to production pack (modbus)
