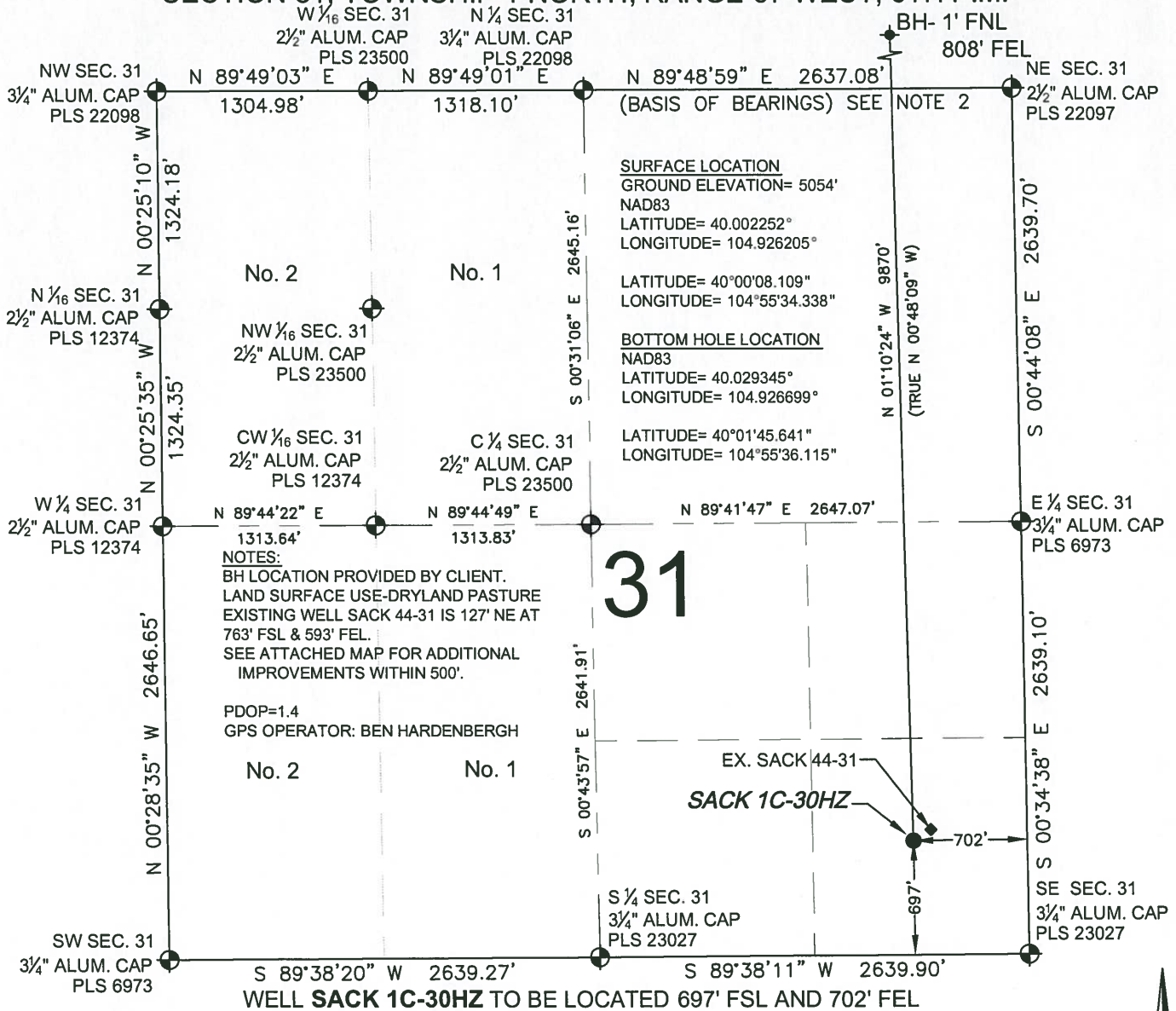


# WELL LOCATION CERTIFICATE: SACK 1C-30HZ
