#### COMMENTS:

The temporary injection equipment being used at the Clough 2A pad for the RWF 911-28D injection well is planned to move to the RMV 205-20 pad in Q1 of 2015 and begin the injection zone prove out process for the RWF 933-19D injection well. Once the zone is proved out we will proceed with installation of a permanent injection system and pipeline. The permanent injection pump will be located in the Rulison Injection plant (COGCC ID 149006) which was previously identified in the Form 31 surface facility diagram. Water for injection will be pumped from the Rulison injection plant to the RWF 933-19D.
