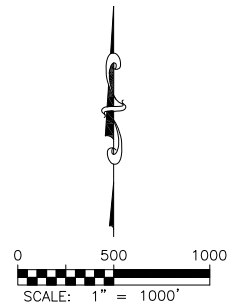
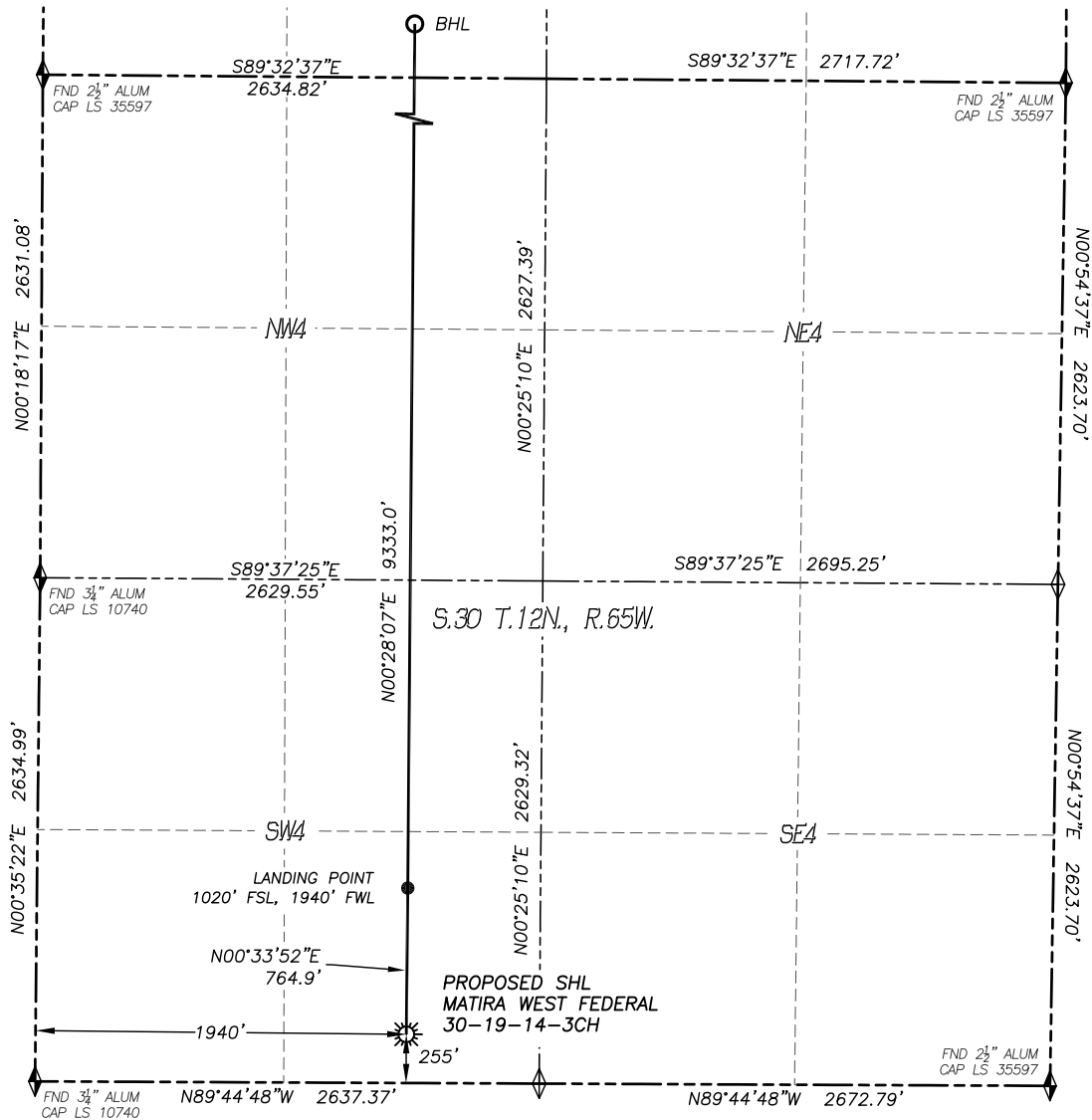


# WELL LOCATION CERTIFICATE

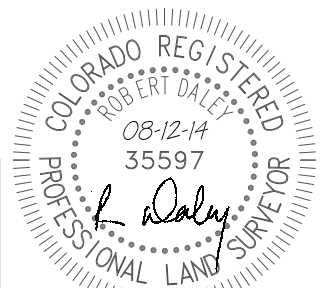

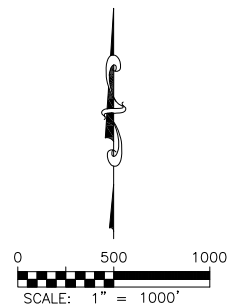
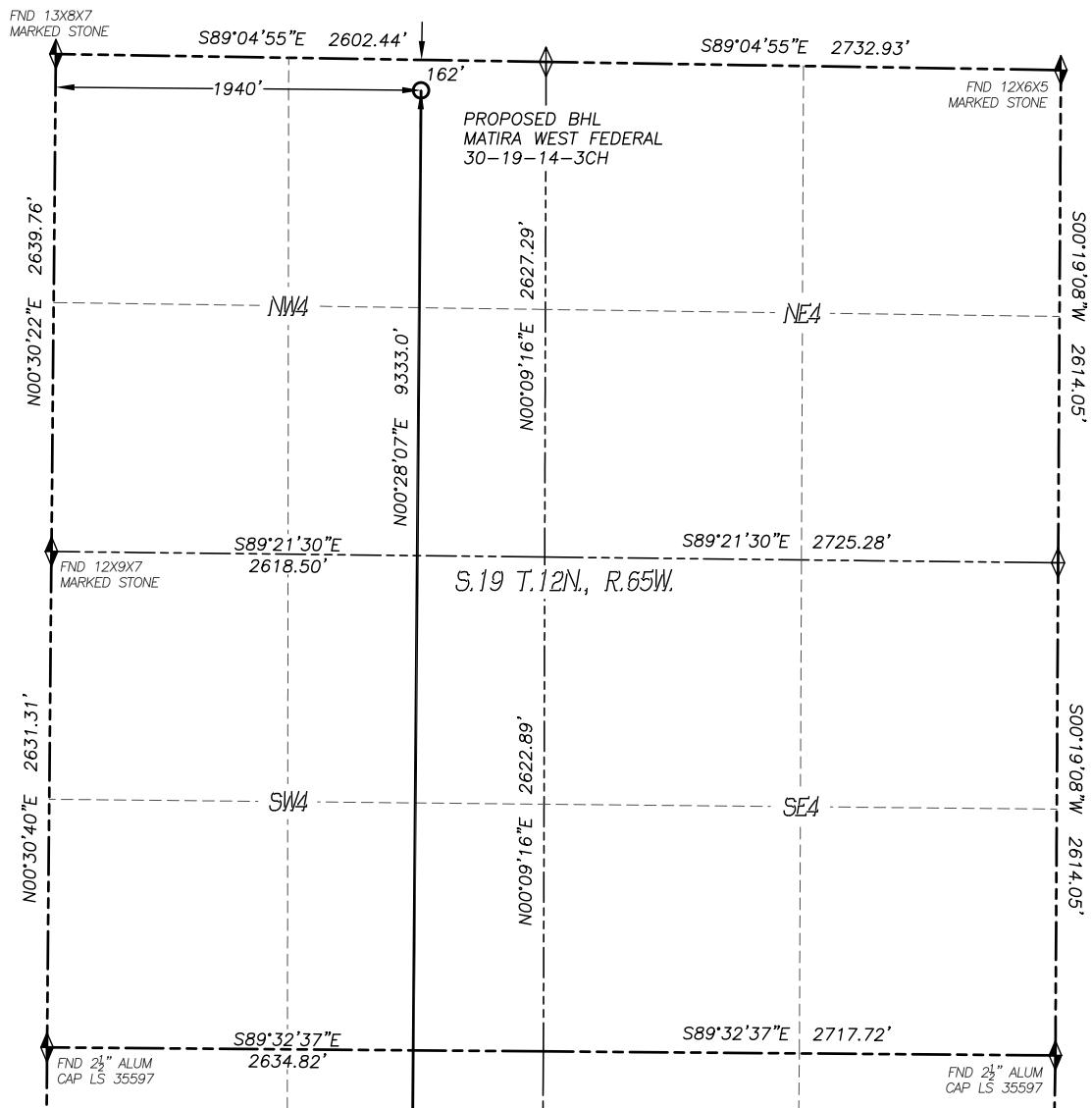
