John Heath, owner of the Subject Lands, for adequate consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby waive the provisions of Rule 318.A. (a) of the Colorado Oil and Gas Conservation Commission's Rules and Regulations that provides that wells shall be drilled within a square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' Window") or a square with sides eight hundred (800) feet in length, the center of which is the center of any governmental quarter section ("800' Window"). John Heath hereby consents and authorizes Bill Barrett Corporation to drill, complete and operate the following wells:

HEATH 6-62-15-0758BH2 being 300 feet FNL and 1090 feet FEL of Section 15, Township 6 North, Range 62 West, 6th P.M., Weld County, Colorado, which surface location is approximately 285 feet outside of the 400' Window of Subject Lands.

HEATH 6-62-15-0758CH2 being 300 feet FNL and 1075 feet FEL of Section 15, Township 6 North, Range 62 West, 6th P.M., Weld County, Colorado, which surface location is approximately 270 feet outside of the 400' Window of Subject Lands.
