Comments

Railroad is more than 5,280 feet from site. There are mobile pivot irrigation towers that pass approximately 378' and 202' northwest of location, with the pivot end pipe approximately 142' northwest of location. Overhead powerlines are approximately 277' east of location. County Road right of way is 367' east of location. Nearest water well is 2,380 feet from site (Receipt:0454458A Permit:223968-- Use: Commercial/Domestic). The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. A pump jack may be necessary to place on facility in the future to help with gas production. It will require either a gas or electric motor to run the pumping jack unit, which will be determined at the time of installation.

This permit is waiting on a spacing application approval and is on the October, 2014 docket of the Colorado Oil and Gas Conservation Commission.
