**COMMENTS:**

This COGCC Form 4 is being submitted in order to permit the re-use of treated E&P waste that is currently stored at the Clough 14-22MV (COGCC Facility #335218), RWF 531-13 (COGCC Facility #335646), and RWF 34-12 (COGCC Facility # 324259). The treated E&P waste was generated during spill remediation activities.

With the COGCC's approval, approximately 4000 yards of treated material would be transported to the Clough 18 well pad and used as a backfill material on another remediation project (Spill tracking # 400666271).

WPX already received the landowner's approval to proceed with the transportation and re-use of the treated E&P waste. The laboratory results for the treated E&P waste are summarized in the attached table. The analytical laboratory reports are included as an attachment.
