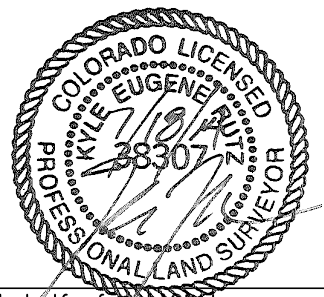

SITE SKETCH

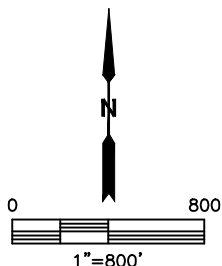
