PIONEER is requesting continued temporarily abandon status on The Bambino 34-36 well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for continued temporarily abandon status was submitted to the COGCC on 3/15/2013. A Mechanical Integrity Test dated 6/7/2012 has also been previously submitted. The Bambino's wellhead is secured and shut-in by a 2" valve at surface and cement retainer set at 785'.
