PIONEER is requesting continued temporarily abandon status on the Pencil 32-20 well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for continued temporarily abandon status was submitted to the COGCC on 3/15/2013. A Mechanical Integrity Test dated 6/6/2012 has also been previously submitted. The Pencil well's wellhead is secured by a 5.5-2 swedge on top with a closed 2" valve and cement retainer at 1409'.
