A Form 4 for continued temporarily abandon status was submitted to the COGCC on 3/15/2013. A Mechanical Integrity Test dated 12/1/2009 has also been previously submitted. The Spaceman well is closed to the atmosphere by wellhead secured and shut-in by a valve as well as a bridge plug set at 680.'
