COMMENTS:

The 8 5/8" casing depth for this well was submitted for 500'. The approved copy was ammended to 587'. A copy of the SUBMITTED APD was mistakenly given to the company man. He should have been given a copy of the APPROVED APD. He set the casing at 542', 45 feet below the approved depth. We plan to set all of our surface casing at 600' as a precautionary from this point forward. We had previously been notified by email for changes on the casing depths and on this well we were not notified. We were told that COGCC will continue to notified us via email of changes and we will set at all surface casing at 600'. This should eliminate the problem on all of Elm Ridge's furture wells.
