The pit associated with this location was backfilled and graded to match existing grade on June 11, 2014 and seeding of the reclaimed area was completed on June 17, 2014. A Form 15 was submitted by BBC to the COGCC on October 12, 2010, in order to permit the pit. To date, no response has been issued. Therefore, there is no Facility ID associated with the pit in the COGCC online database. BBC received approval from Carlos Lujan of the COGCC to close and reclaim the pit on October 17, 2013 under remediation #8026.
