

PROCEED IN AN EASTERLY DIRECTION FROM EATON, COLORADO ALONG E COLLINS STREET/COUNTY ROAD 74 APPROXIMATELY 0.8 MILES TO THE JUNCTION OF THIS ROAD AND COUNTRY ROAD 39 TO THE NORTH; TURN LEFT AND PROCEED IN A NORTHERLY DIRECTION APPROXIMATELY 4.0 MILES TO THE JUNCTION OF THIS ROAD AND HIGHWAY 14 TO THE EAST; TURN RIGHT AND PROCEED IN AN EASTERLY DIRECTION APPROXIMATELY 4.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 47 TO THE SOUTH. TURN RIGHT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 0.6 MILES TO THE BEGINNING OF THE PROPOSED ACCESS ROAD TO THE WEST; FOLLOW ROAD FLAGS IN A WESTERLY DIRECTION APPROXIMATELY 71' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM EATON, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 9.4 MILES.




