COMMENTS:

The purpose of this sundry notice is to change the Remediation Workplan Form 27 (Remediation # 7714) for the GM 21-2 condensate spill and historical release (Spill tracking #s 2231027 and 2231028).

Instead of the in-situ remediation treatment, that was proposed in the approved Form 27, WPX would like to excavate and landfarm the impacted material. Based on the soil sample data obtained from multiple boreholes drilled during the site investigation and the in-situ remediation process, an estimated 1,000 cubic yards of soil exceed COGCC Table 910-1 standards for hydrocarbons (see attached drawing). The excavated soil will be treated with a bio-remediation product in order to reduce hydrocarbon contaminant levels below COGCC Table 910-1 standards. The material will be landfarmed at the GM 21-2 well pad.
