The 30 mil liner will be a contiguous liner which will underlay the entire tank battery.</li> <li>3) The tank battery / water vault liner will be keyed into a galvanized steel containment ring installed surrounding the tank battery.</li> <li>4) Sand bedding will be installed to protect the synthetic liner prior to placing equipment in the containment area.</li> </ol>
