Comments Railroad is more than 5,280 feet from site. There are no visible improvements within 500 feet. Nearest water well is 3,485 feet from site (Receipt:9054767 Permit:48434- - Use:Stock). The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. A pump jack may be necessary to place on facility in the future to help with gas production. It will require either a gas or electric motor to run the pumping jack unit, which will be determined at the time of installation.
