Operator requesting to drill second vertical well 147' from existing producing oil well the Ma-State # 8 which produces from the Cherokee A formation. The proposed Ma-State # 8S will not produce from the Cherokee A formation. Minimum additional surface disturbance will be required to drill the Ma-State # 8S. Drilling pits will be within original disturbed area of the Ma-State# 8 well. Nearest water well 5280'. Barb wire fence 280' west of well pad and shallow surface water depression which is dry located 1615' from well stake, both sites will not be disturbed by drilling operations. Building 4648' from well stake is unoccupied structure that contains production equipment for Aloha Mula Gas Plant.
