I have reviewed the referenced Form 2A Oil and Gas Location Assessment and have the following comments.

- 1) When you have submitted the Form 2A for the Cottonwood 08 Production Pad, please let me know and I will add that Document # to the Related Remote Locations section of the Form 2A.
- 2) It appears that a portion of this proposed oil and gas location will be on lands with a slope of 10% or greater. Therefore, per COGCC Rule 303.b.(3)I, please provide me with a Construction Layout Drawing that also includes a location cross section plot.
- 3) Per COGCC Rule 303.b.(3)F, the Access Road Map shall show the access road from the highway or county road to the proposed oil and gas location. Your Access Road Map does not show the access road as it comes off a highway or County Road. Please send me a revised Access Road Map that shows this.
