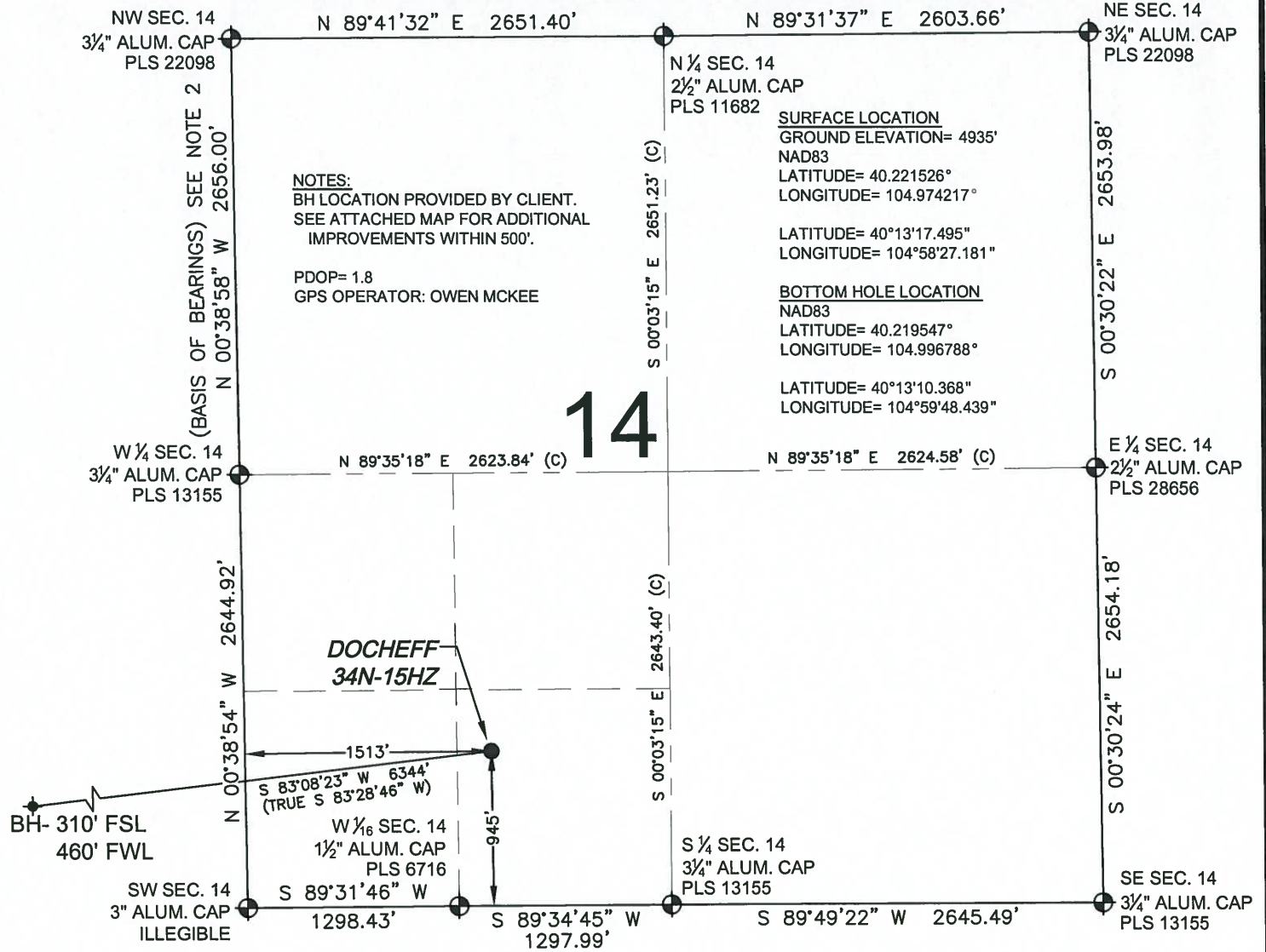


WELL LOCATION CERTIFICATE: DOCHEFF 34N-15HZ

- ◆ = EXISTING WELL

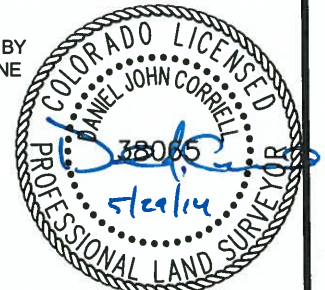
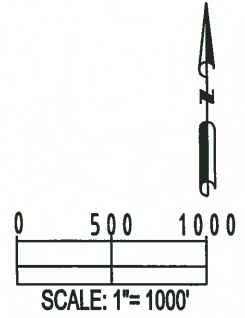
