#### COMMENTS:

Chevron U.S.A. Inc. (Chevron) is requesting continued shut-in status for the subject well. The well was shut-in after drilling and is waiting on Completion. For economic reasons, Chevron has deferred well completions on the well until 2017. Once completed, the subject well will be put on production.

The subject well had a successful MIT on 09/29/2010. The well is isolated from atmosphere by shut in valves on the tree assembly: two Tubing Valves to isolate tubing and two gate valves to isolate casing.

Production equipment is on location and ready for installation. Installation of production equipment will commence immediately prior to pending well completion. The subject well is not tied into any production equipment at this time.
