Comment: **Steep cut and fill slopes on the well pad are not stabilized and are eroding sediment onto the well pad, down the access road, and off of the project area. There is a gully forming within the southwestern corner fill slope where stormwater flows are concentrated. Erosion from the access road appears to be accelerating erosion within the roadside ditch at the entrance to the project area as bank incision below the culvert is greater than above the culvert. See attached photos.**

CA: **Steep cut and fill slopes on the well pad need to be stabilized and stormwater flows exiting the well pad need to be de-energized and filtered. Gullying in the southwestern corner and downstream from the culvert at the entrance to the project area may need to be repaired to prevent continued, accelerated erosion.**

## **ACTION REQUIRED**

**ANY ACTION REQUIRED** items listed on this report indicate that the oil and gas facility or the oil and gas operations listed on the report may be in violation of the rules and regulations of the Colorado Oil and Conservation Commission (“COGCC”) and corrective action is required.

There is reasonable cause to believe that a violation of the Oil and Gas Conservation Act, or of any rule, regulation, or order of the Commission, or of any permit issued by the Commission, has occurred. The Operator’s compliance with this Inspection Report is required to resolve these alleged violations. This document requires the Operator to timely respond to the COGCC and to comply with directives as listed by the **Corrective Action Deadline Date**. Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1. (Please note that the COGCC's penalty authority was recently increased to a maximum of \$15,000 per day and penalties are no longer capped at a maximum of \$10,000 per violation.)
