Noble is working with Anadarko to deliver production from the Cinque wells to their pipeline. They are requiring a separator be installed prior to Noble hooking up to their pipeline. Anadarko will be permitting the addition of the pipeline from Noble's Cinque Federal 8-31 location to their main pipeline. The addition of the separator will be within the current disturbance. An updated inventory and an aerial of the location showing the separator placement is attached.
