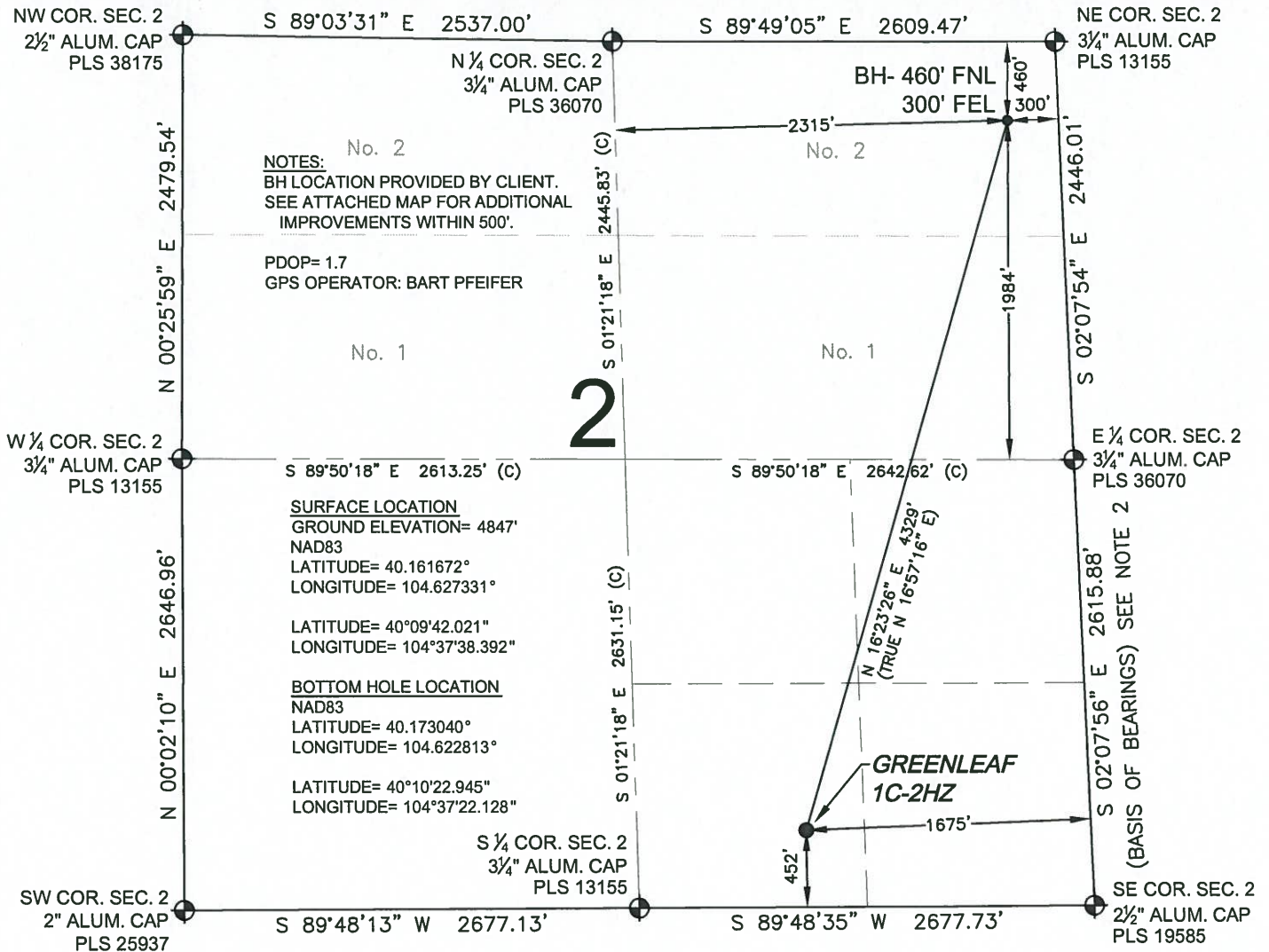


WELL LOCATION CERTIFICATE: GREENLEAF 1C-2HZ

- BH = BOTTOM HOLE



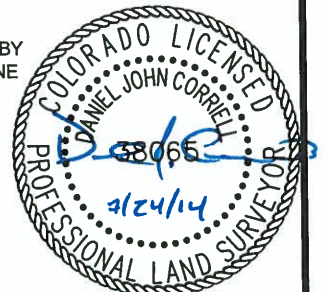
