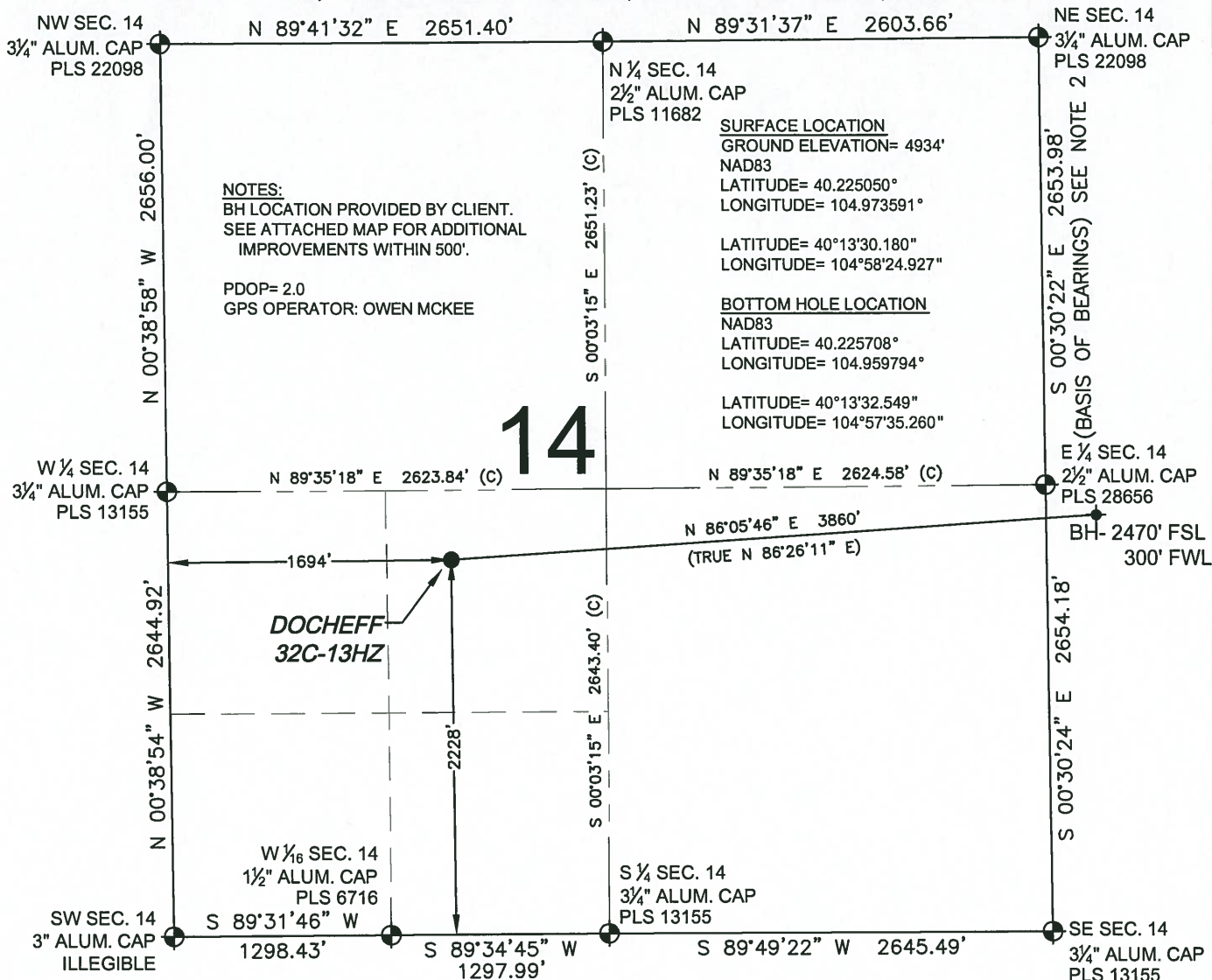


WELL LOCATION CERTIFICATE: DOCHEFF 32C-13HZ

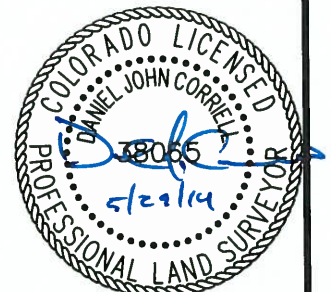
