- 1) MIRU Workover rig, pump & tank.
- 2) Control well with kill fluid
- 3) POOH 2 3/8" tubing
- 4) RIH w/ Bit & Scraper. Tag fill if any. Clean out to PBTD (tally in). TOOH
- 5) RIH w/RBP. Set RBP @ +/-7240' spot 2 sx of sand on top of RBP. Test RBP 2,000psi. TOOH
- 6) Bleed off bradenhead, unland casing
- 7) RIH 1 1/4" tubing down annulus w/ mule shoe to TOC (+/- 1816'), condition hole
- 8) RU cement crew, pump 375 sxs cement, bringing cement to +/- 775'
- 9) POOH above 775' roll hole clean, leaving bradenhead "open". POOH with 1 1/4" tubing, land casing.
- 10) SI well & WOC (at least 4 hours, but preferably overnight), run CBL recording new cement depths
- 11) Clean out hole, retrieve RBP
- 12) Hydro test in 2 3/8" tubing, seat nipple, and notched collar (Remove existing blade bit). Seat nipple set depth of 7490'.
- 13) RDMO. Return well to production under pumper guidance
