Comment: Large cobble and straw wattle BMP within the southern portion of the interim reclamation area appears to be sufficiently de-energizing and filtering concentrated stormwater flows exiting the well pad. Some rill erosion is occurring in other areas on both the cut and fill slopes. These areas need to be monitored and additional stormwater BMPs applied if needed.
