COMMENTS:

This Permit was originally approved July 24, 2013 for the previous Operator-Dejour Energy (USA) Corp. However, due to a change of operator, personnel and Best Management generally accepted drilling practices and procedures, a revised drilling plan is now being submitted to accurately reflect the well construction details.

The major change in this revised Drilling Plan is an increase in the surface hole size from 12-1/4" to 13-1/2", and an increase in the surface casing size from 8-5/8" 24# to 9-5/8" 36#. This results in a stronger string of surface casing with more protective cement sheath.

The other minor change is that the drilled production hole size will be 8-3/4" instead of 7-7/8". This too, will result in more protective cement in the 8-3/4" x 4-1/2" annular area. In addition, better bit selection and availability, longer lasting bits, and better directional drilling efficiency can be realized in the larger 8-3/4" hole size.
